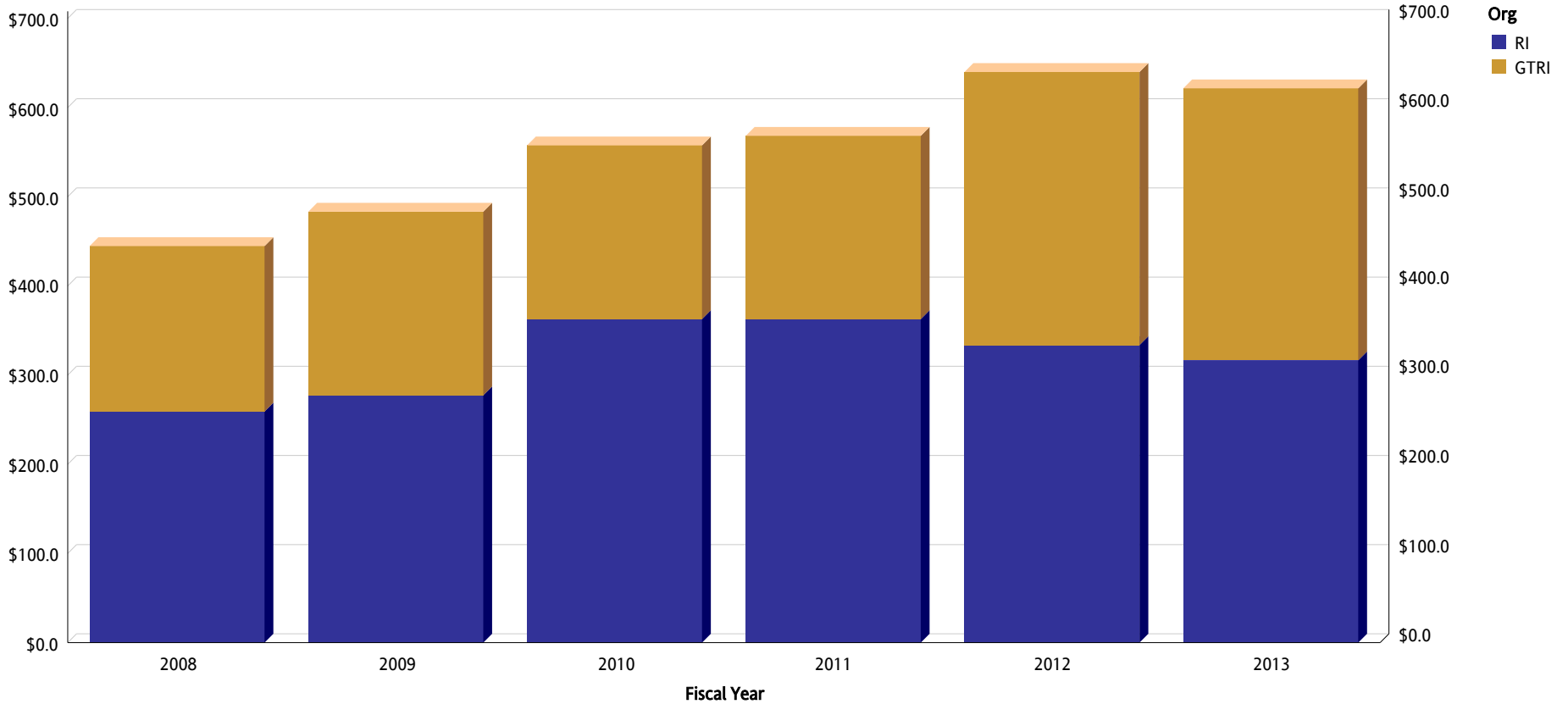

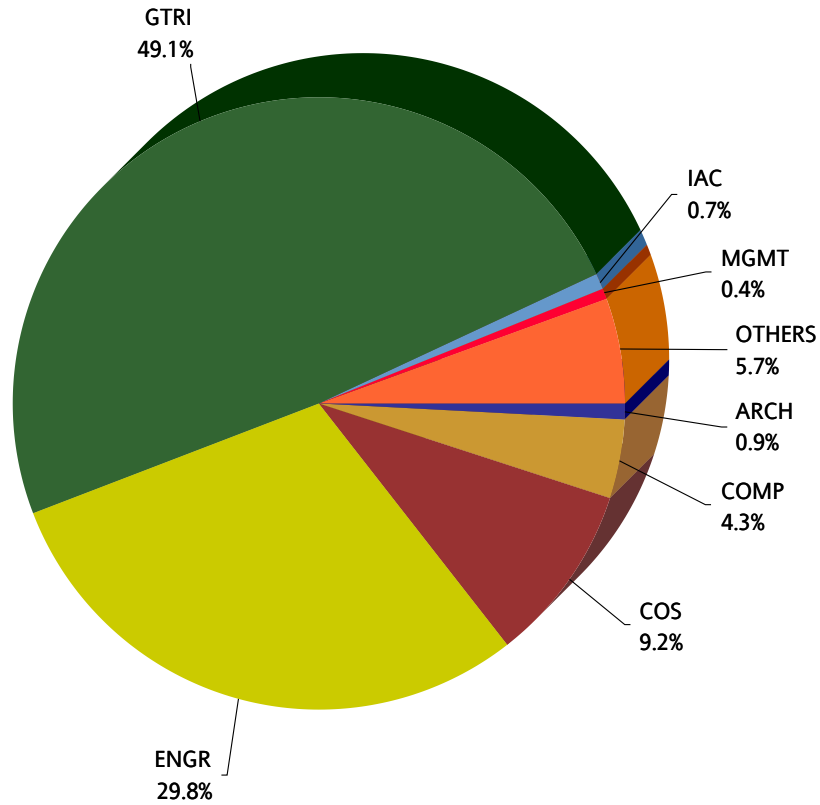

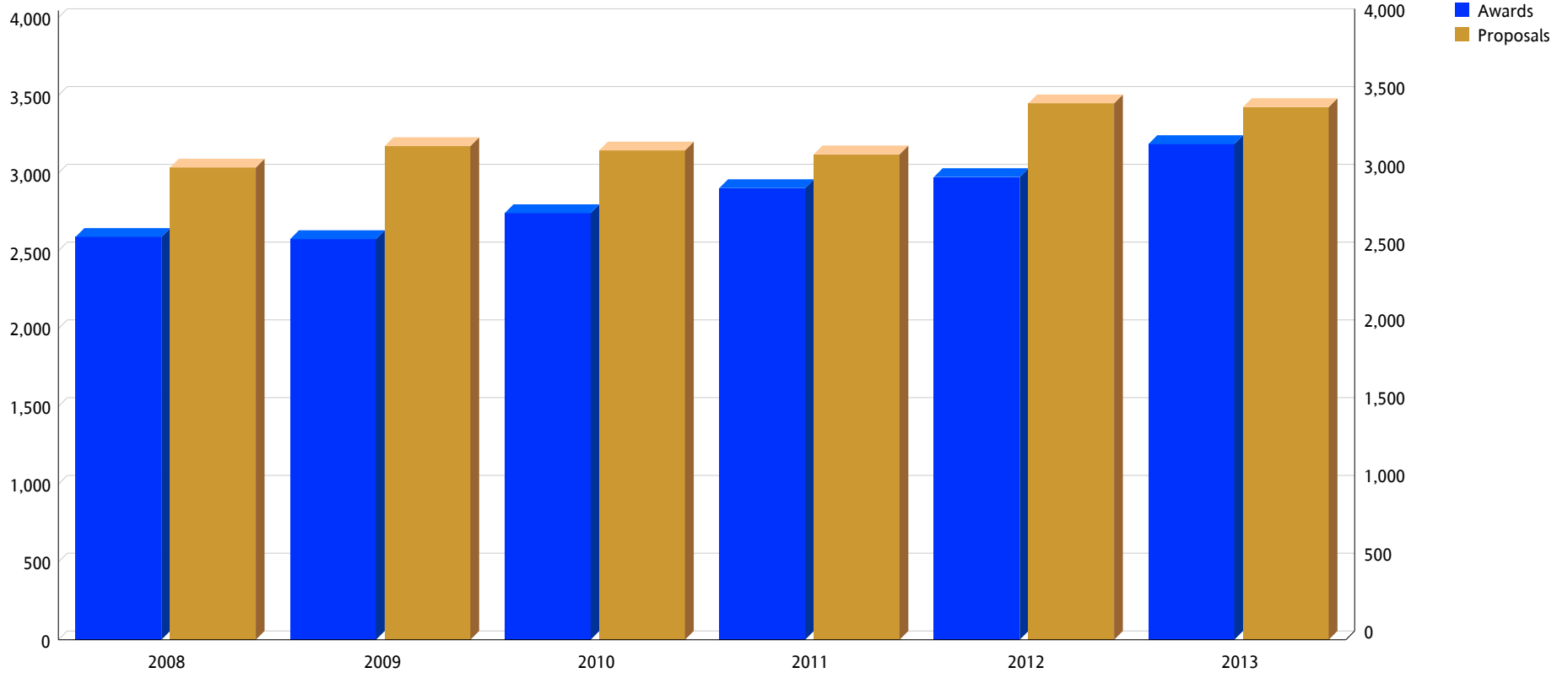

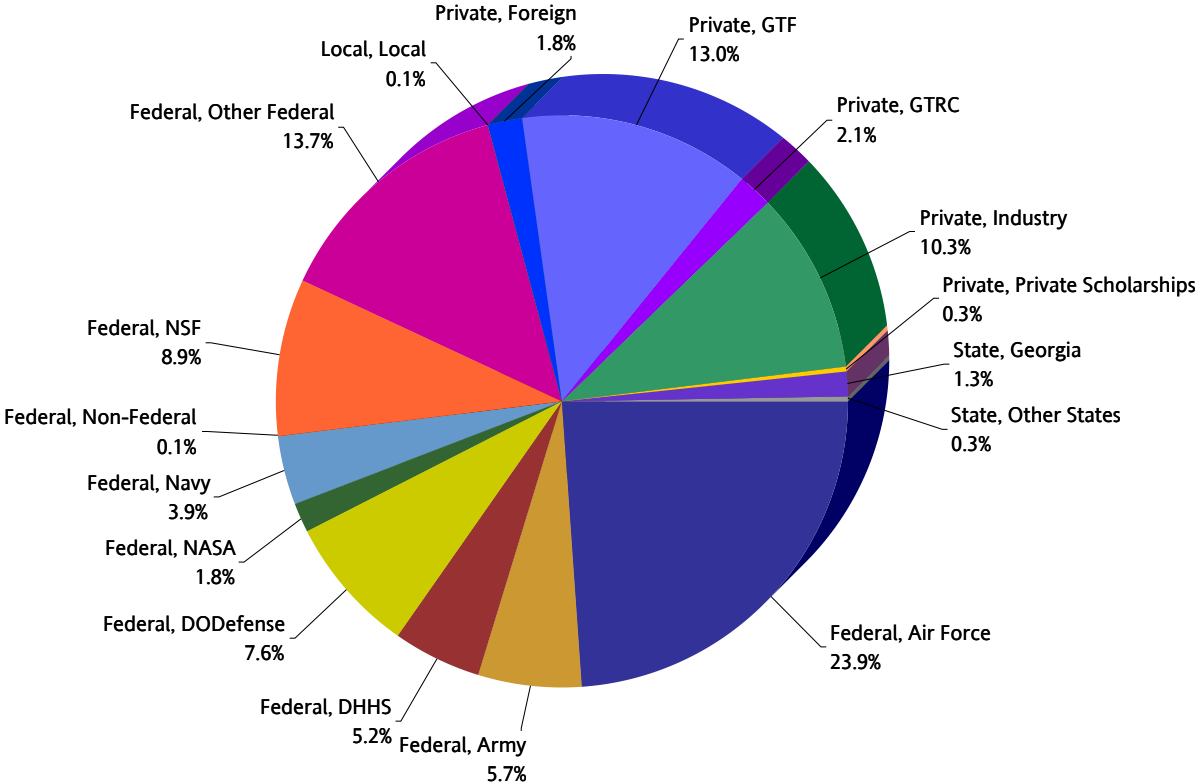

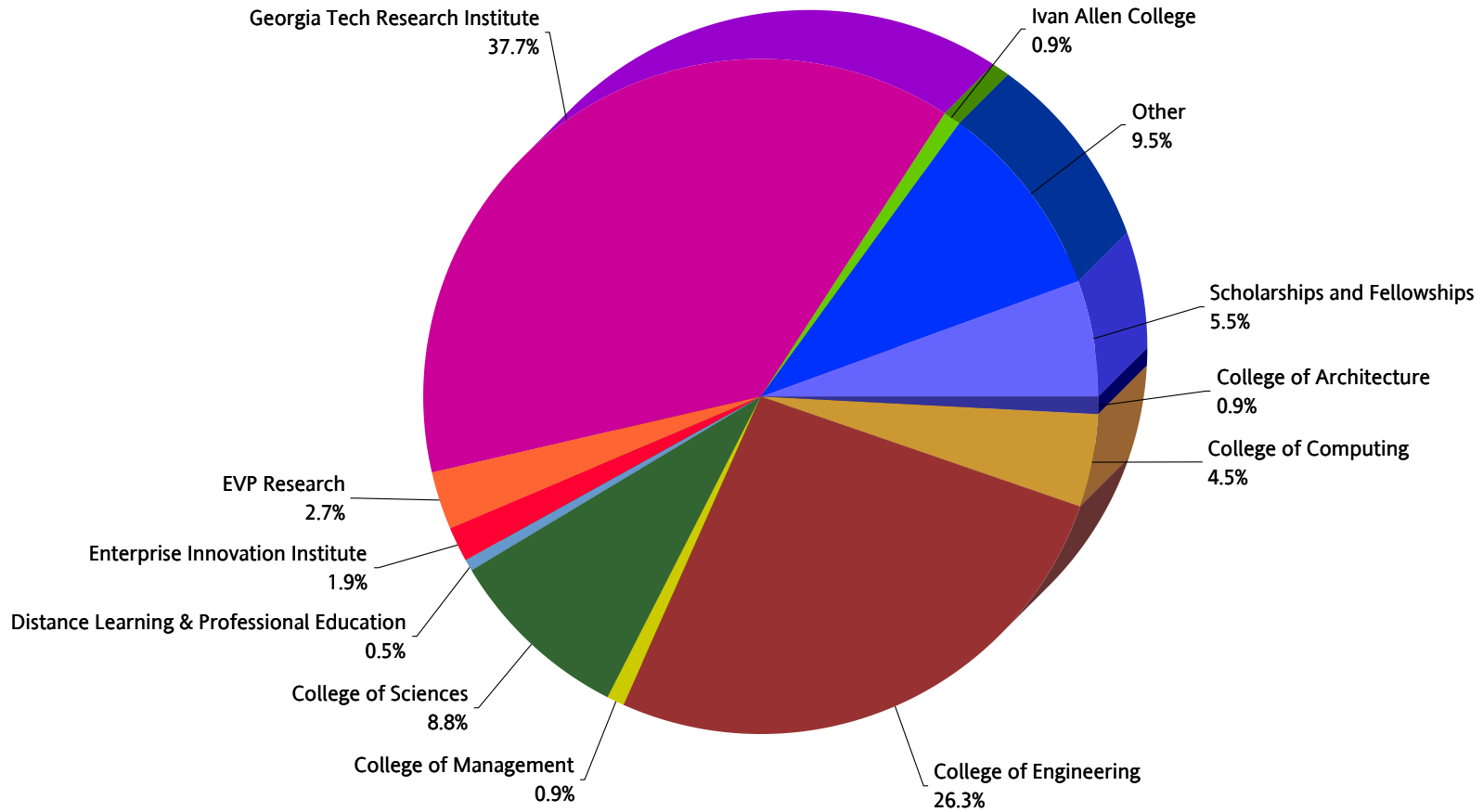

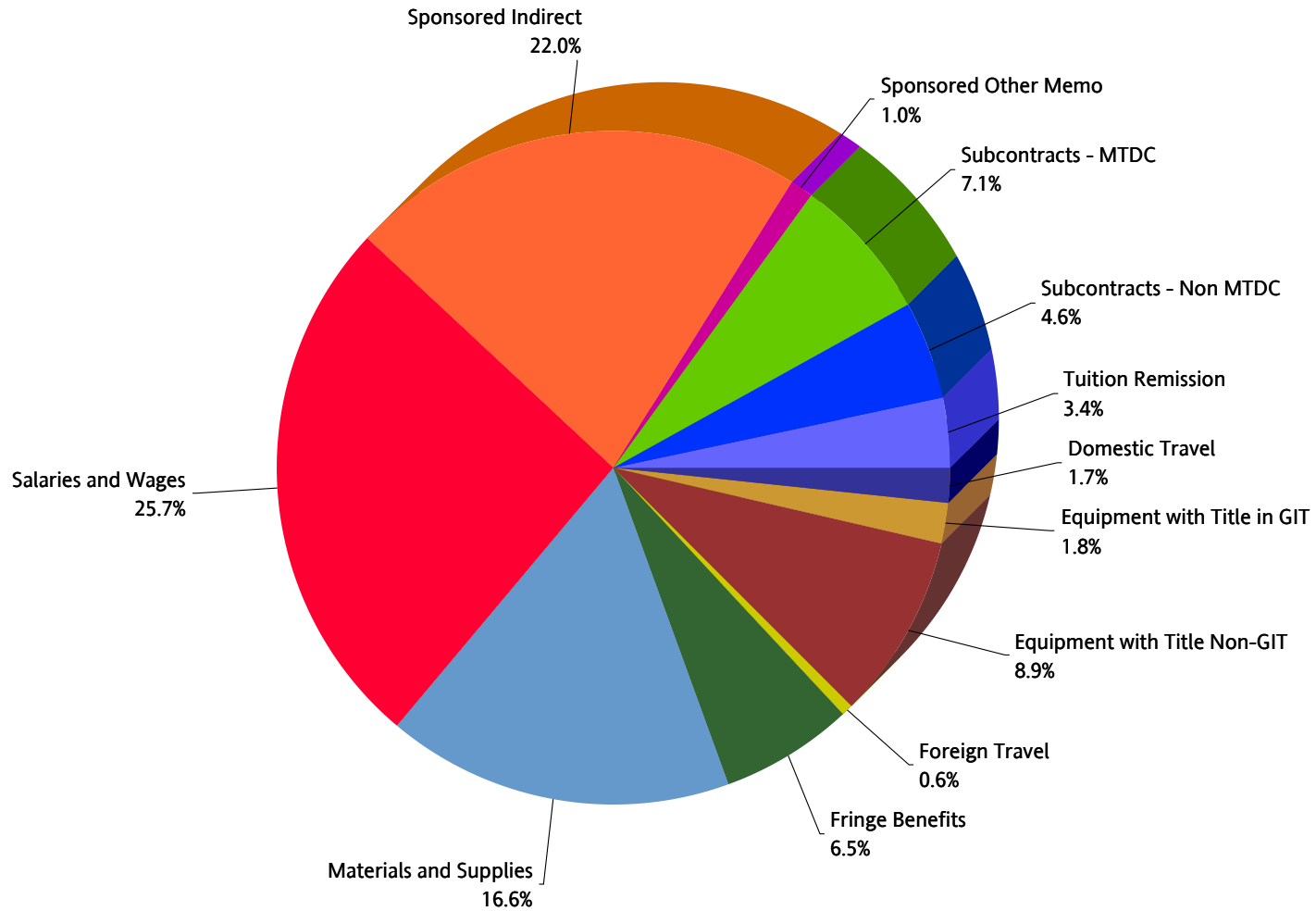

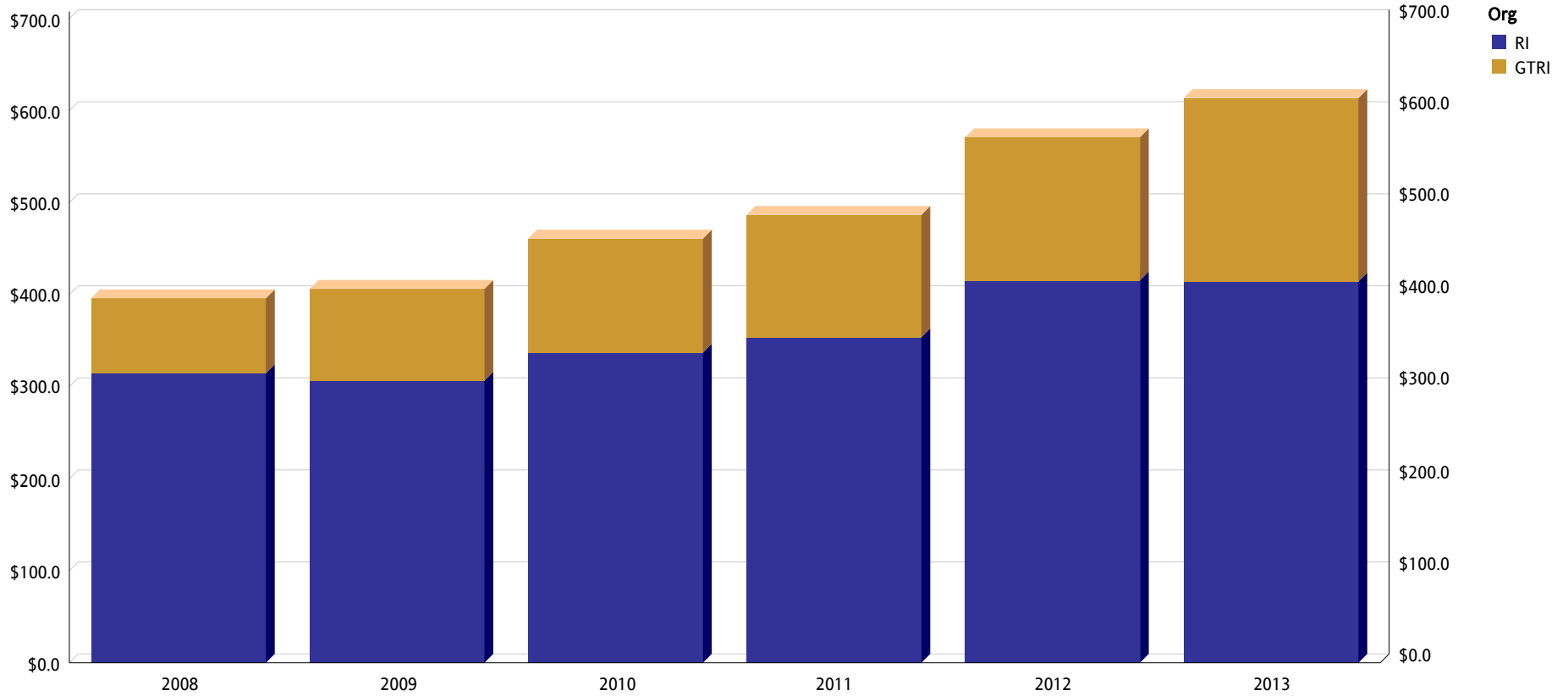

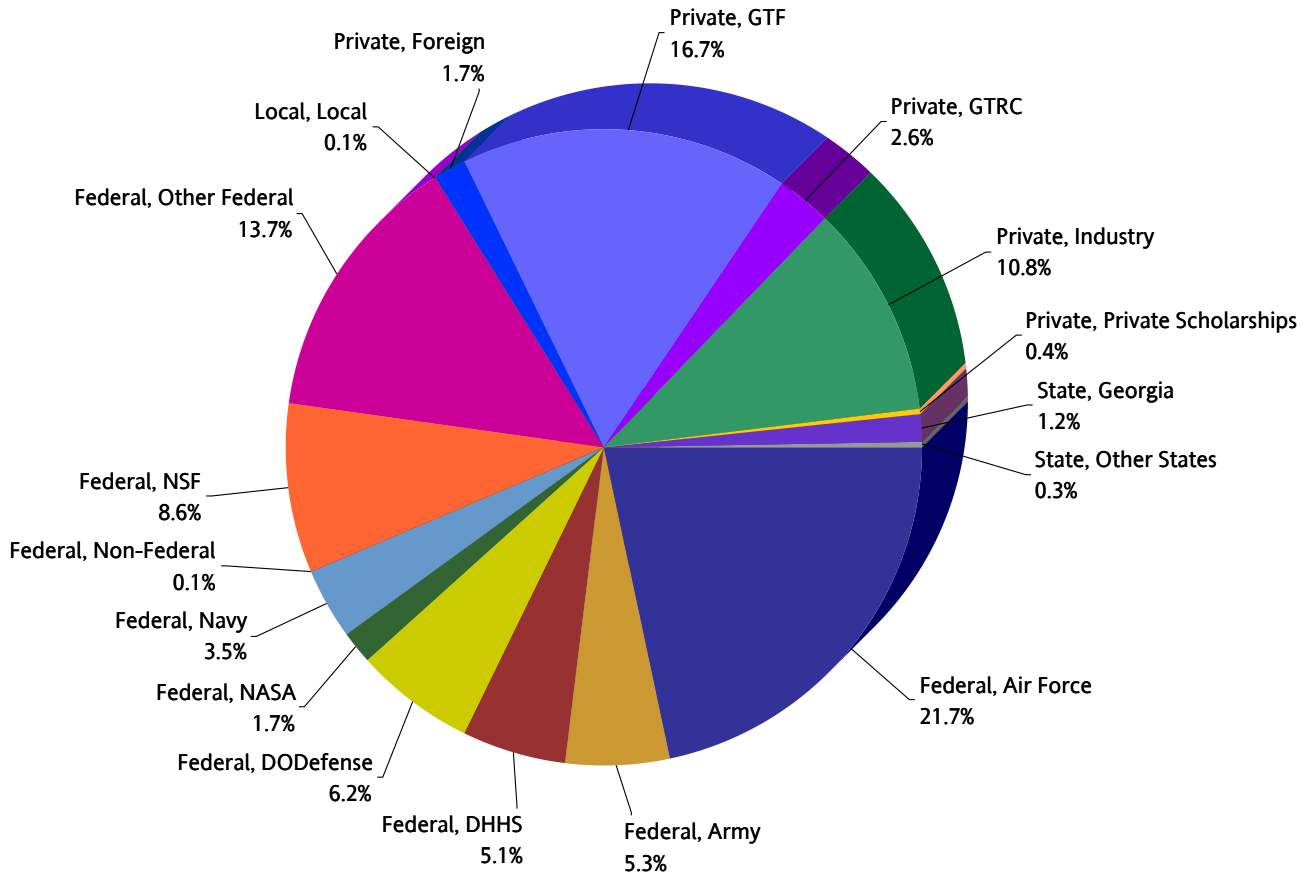

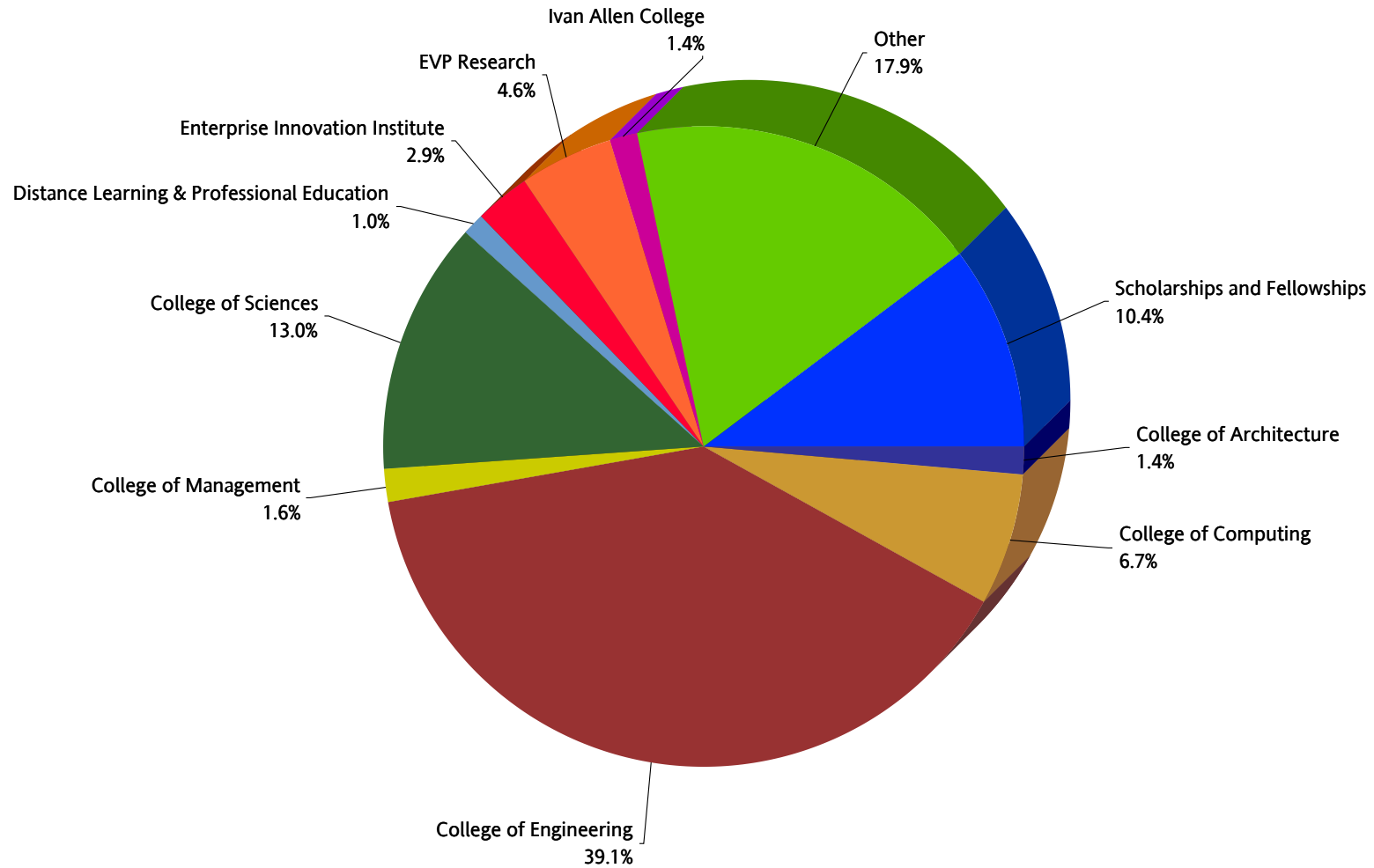

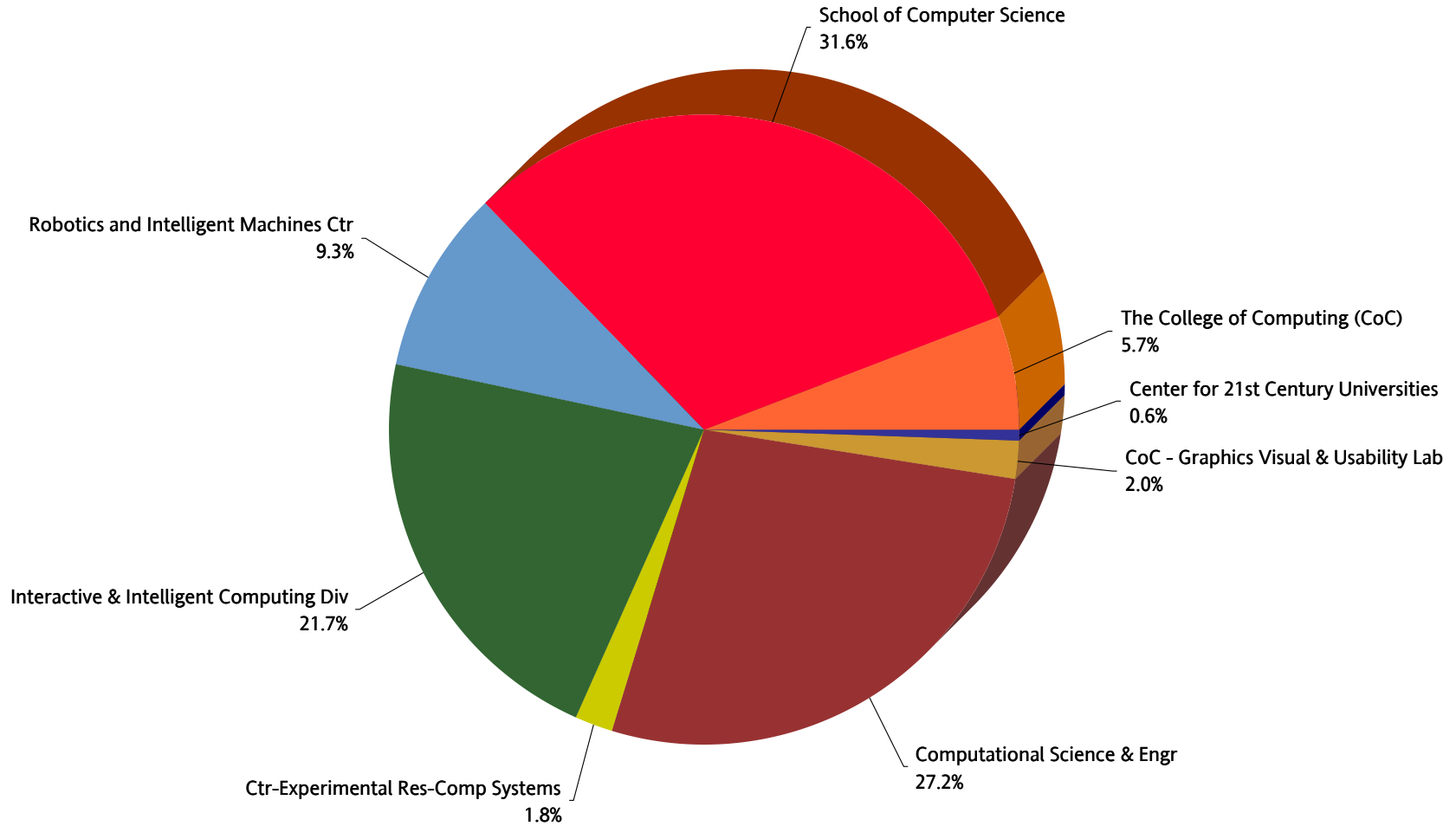

TOTAL \$27,826,000

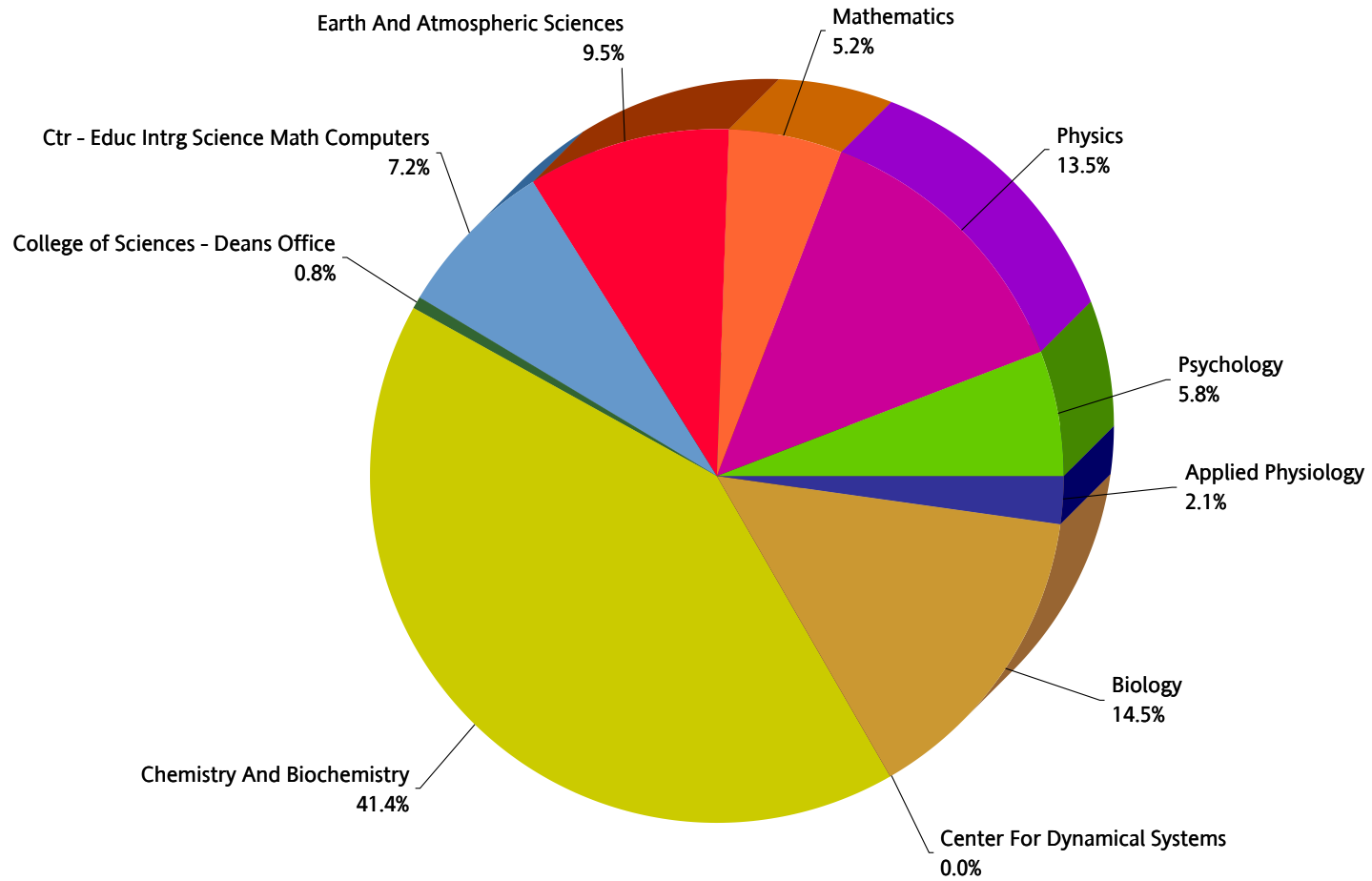

TOTAL \$53,776,000

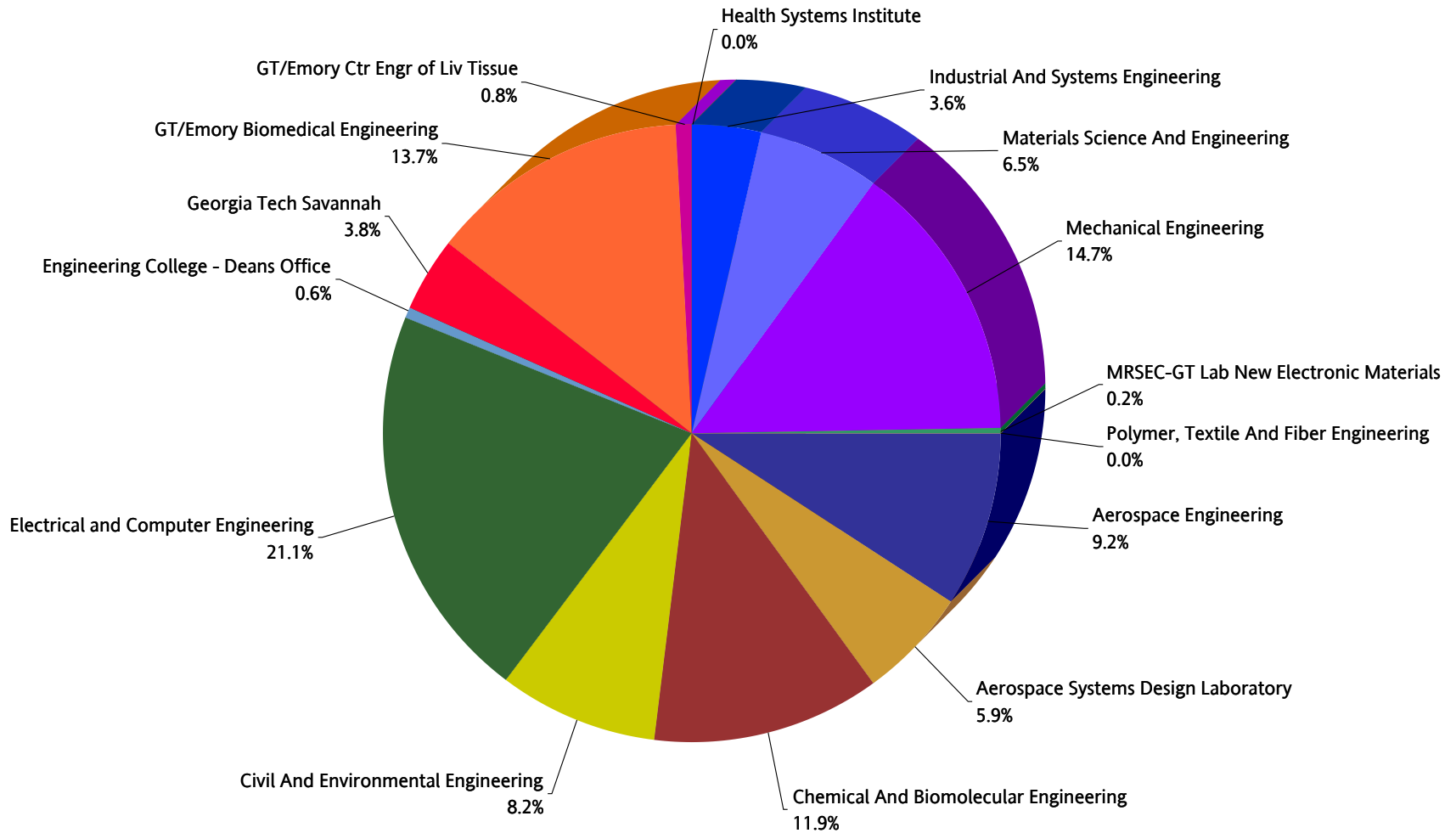

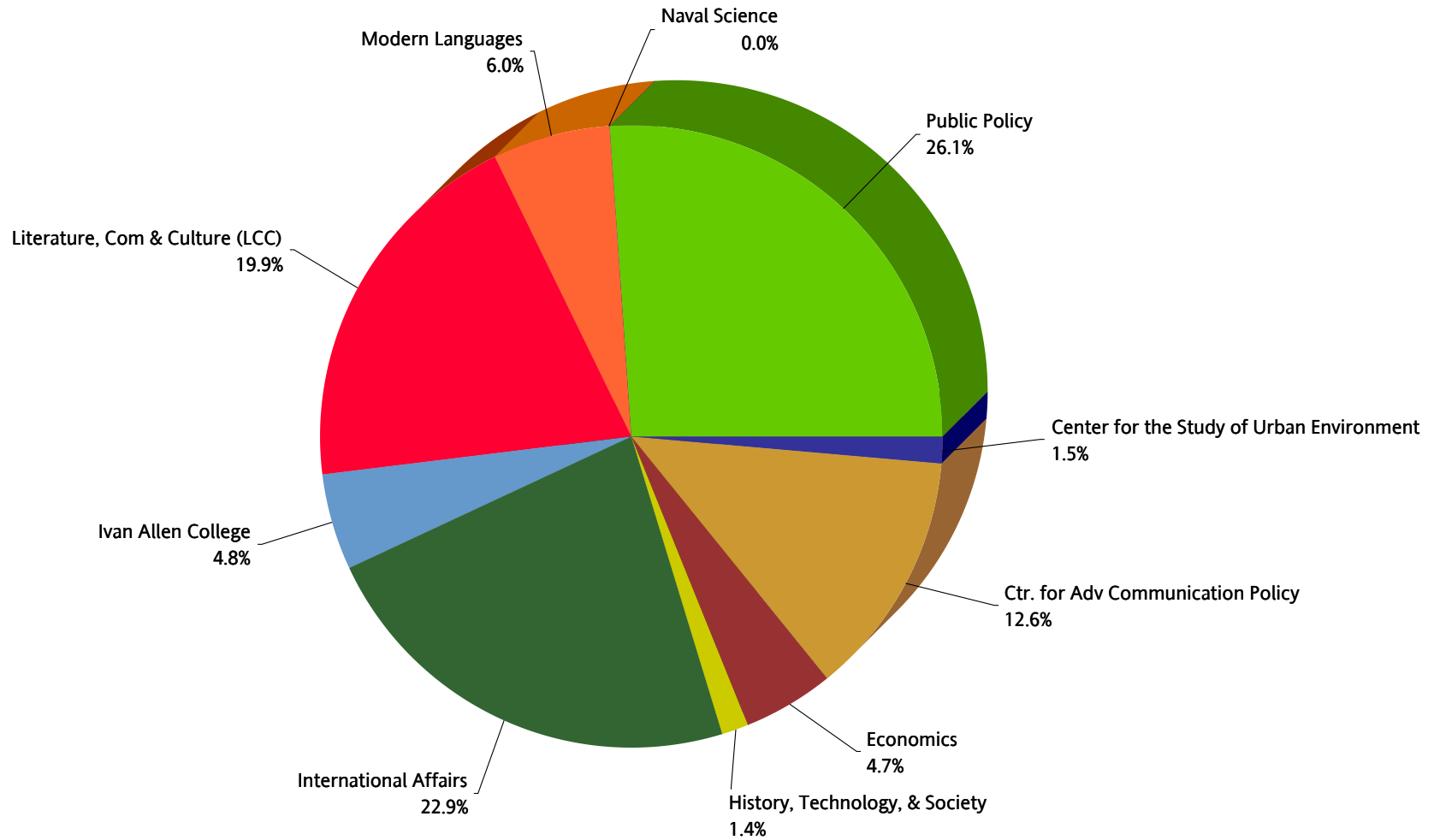

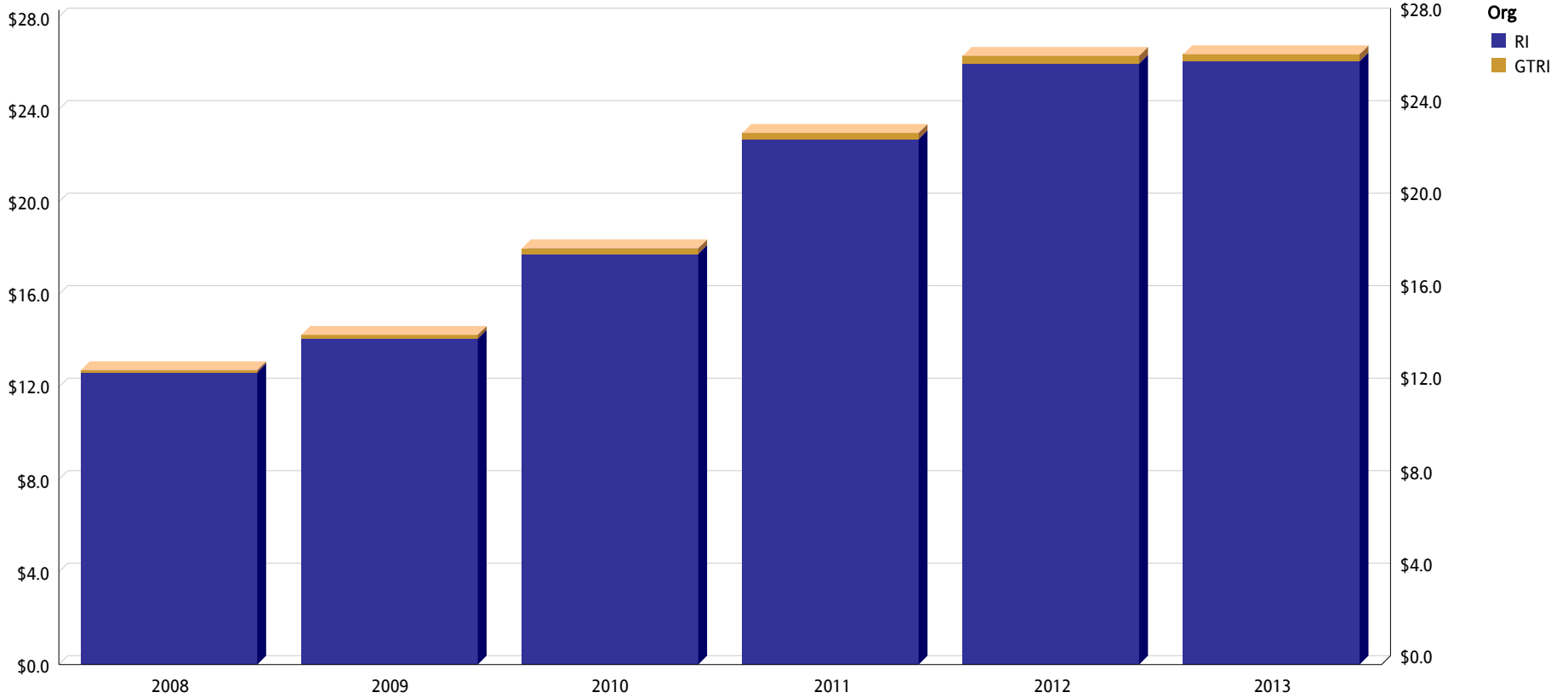

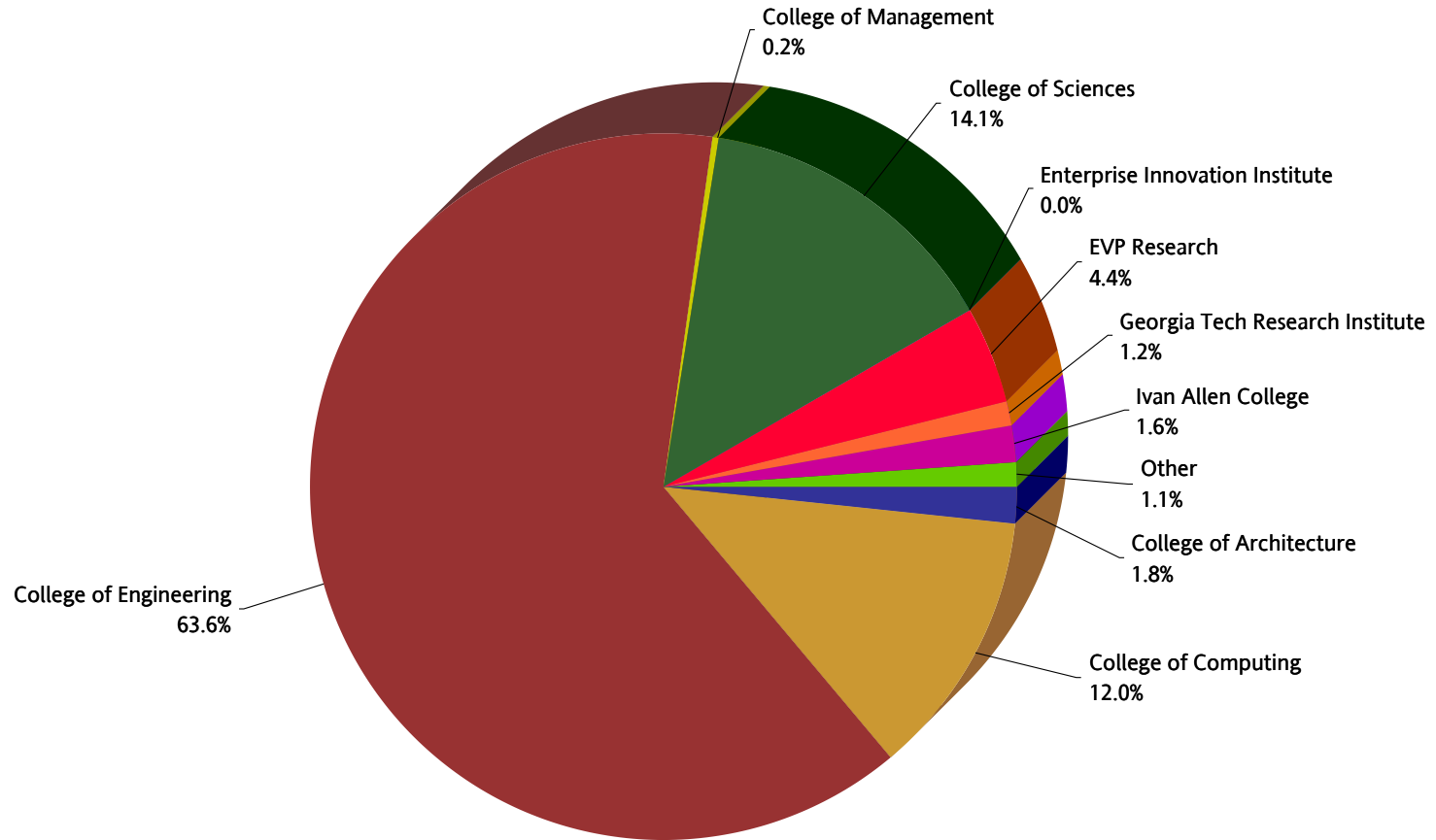

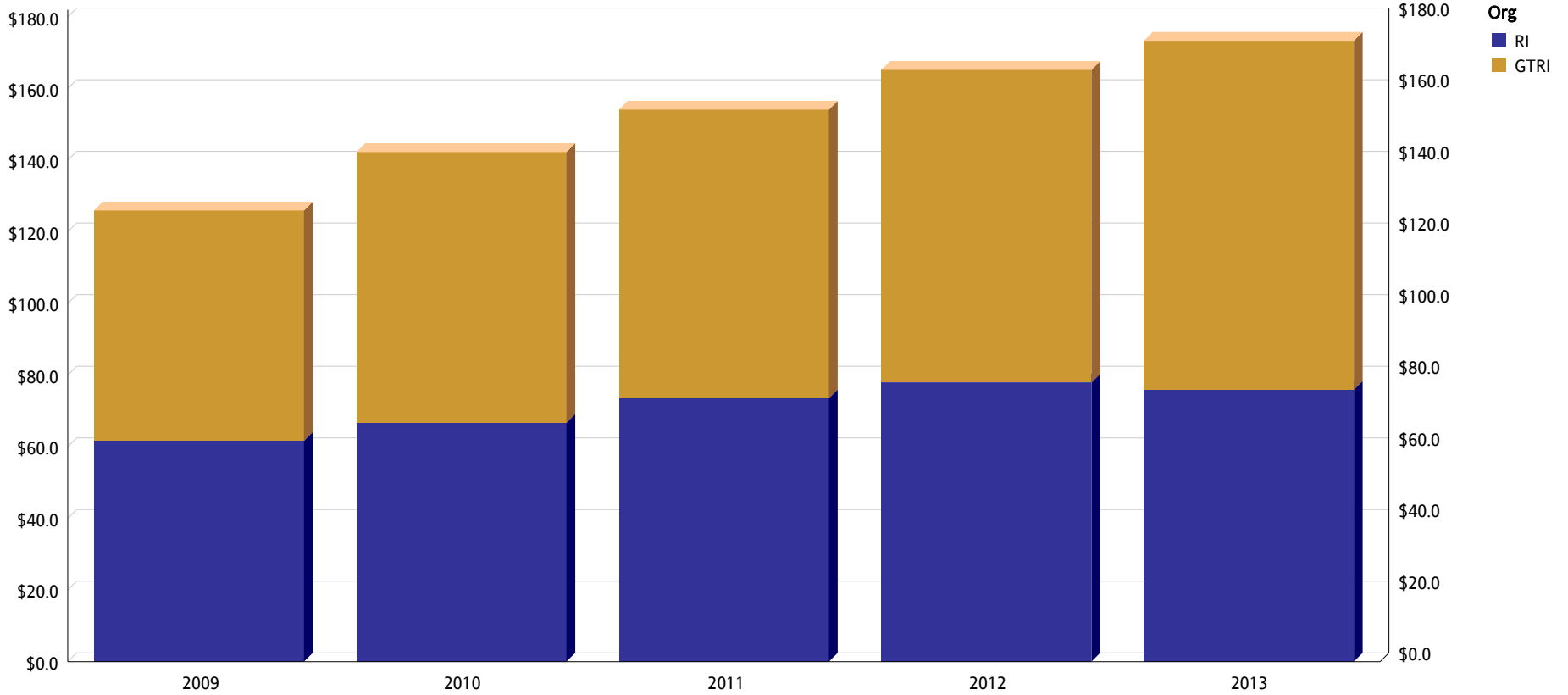

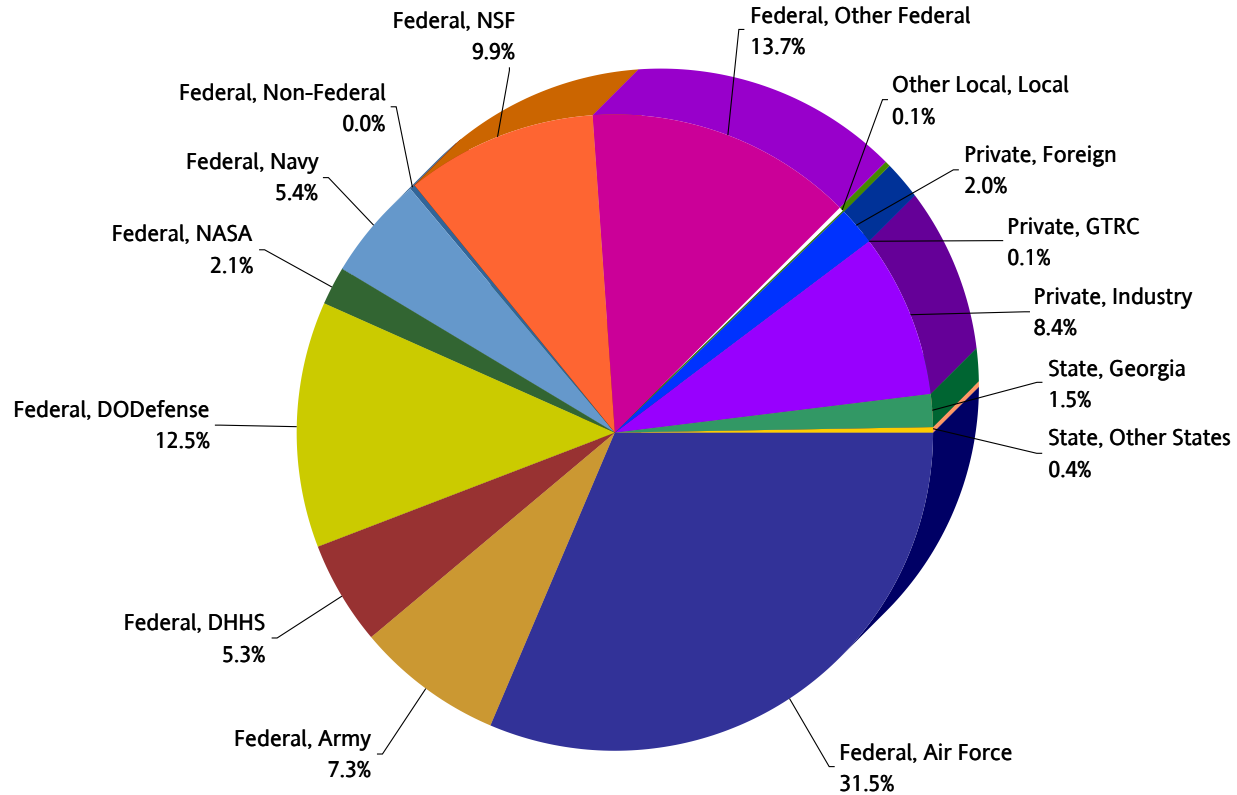

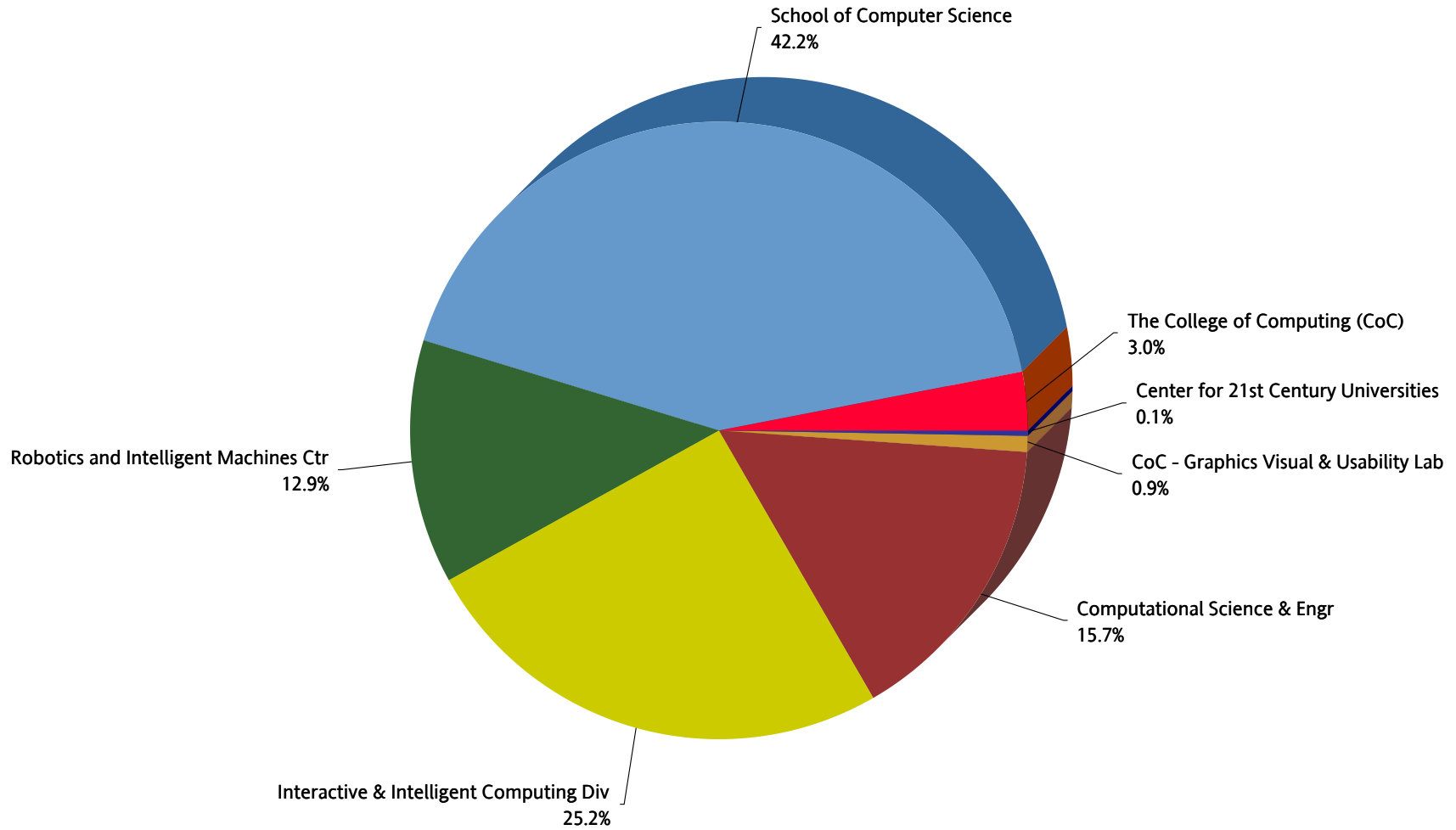

TOTAL \$7,439,000

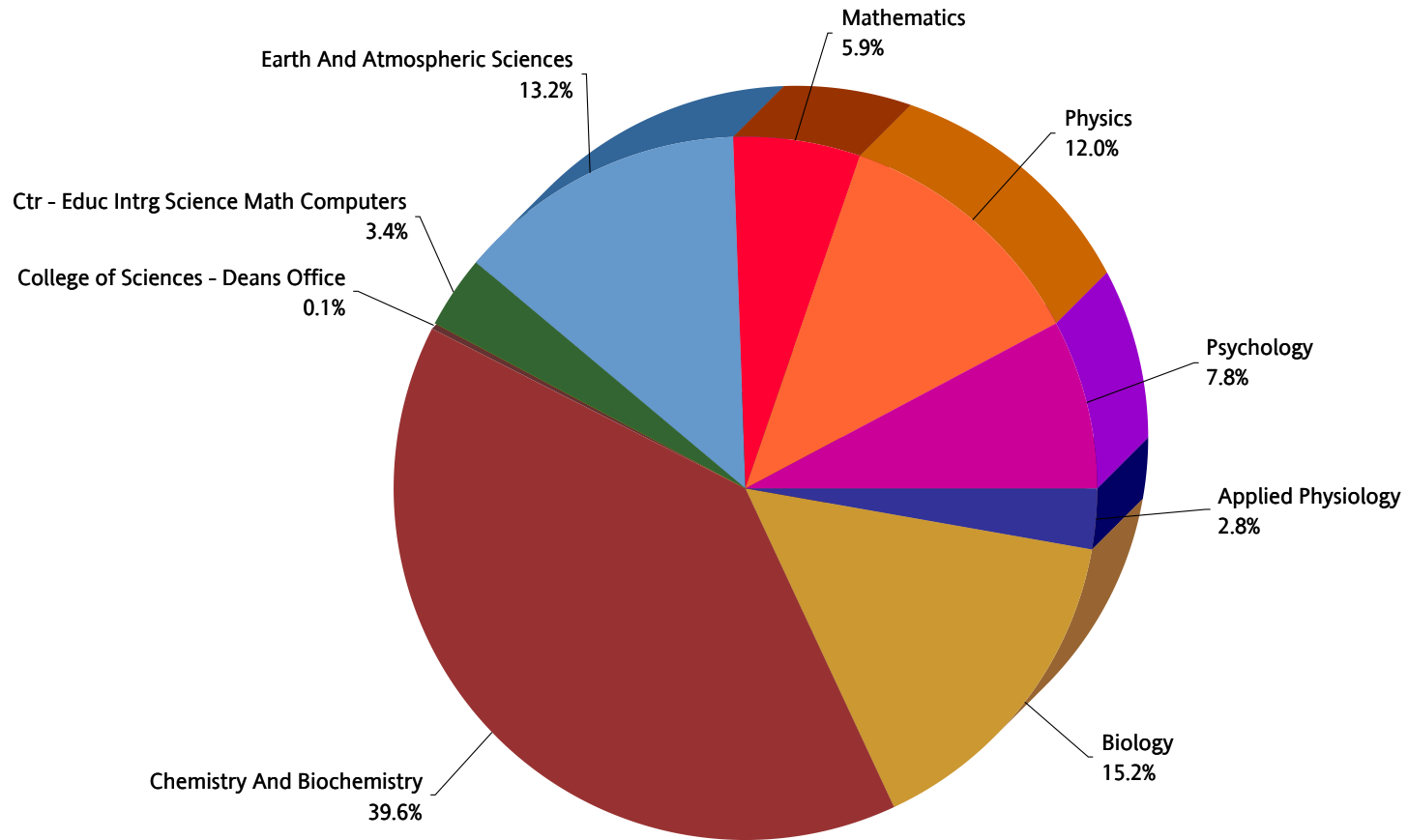

TOTAL \$15,387,000

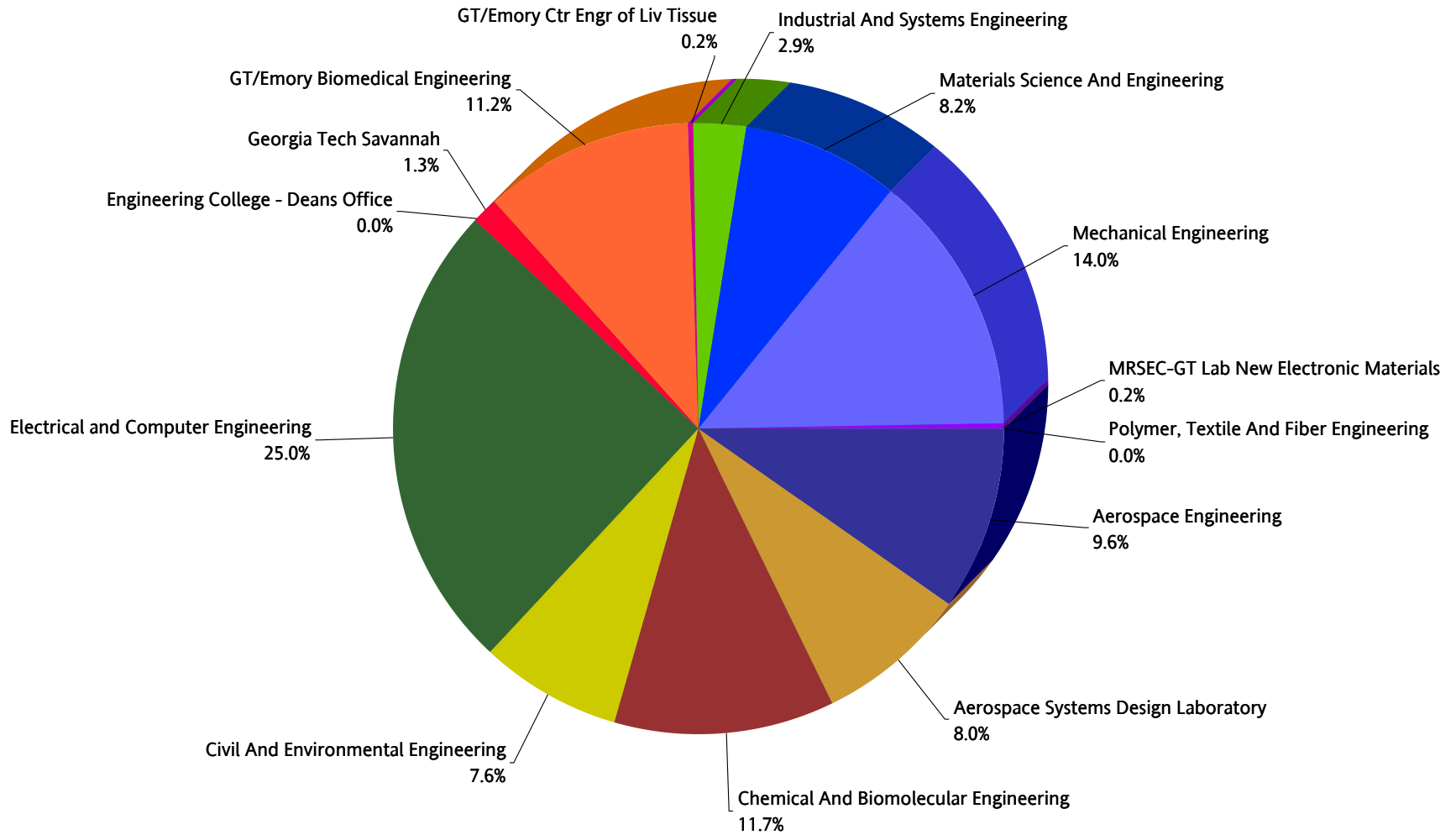

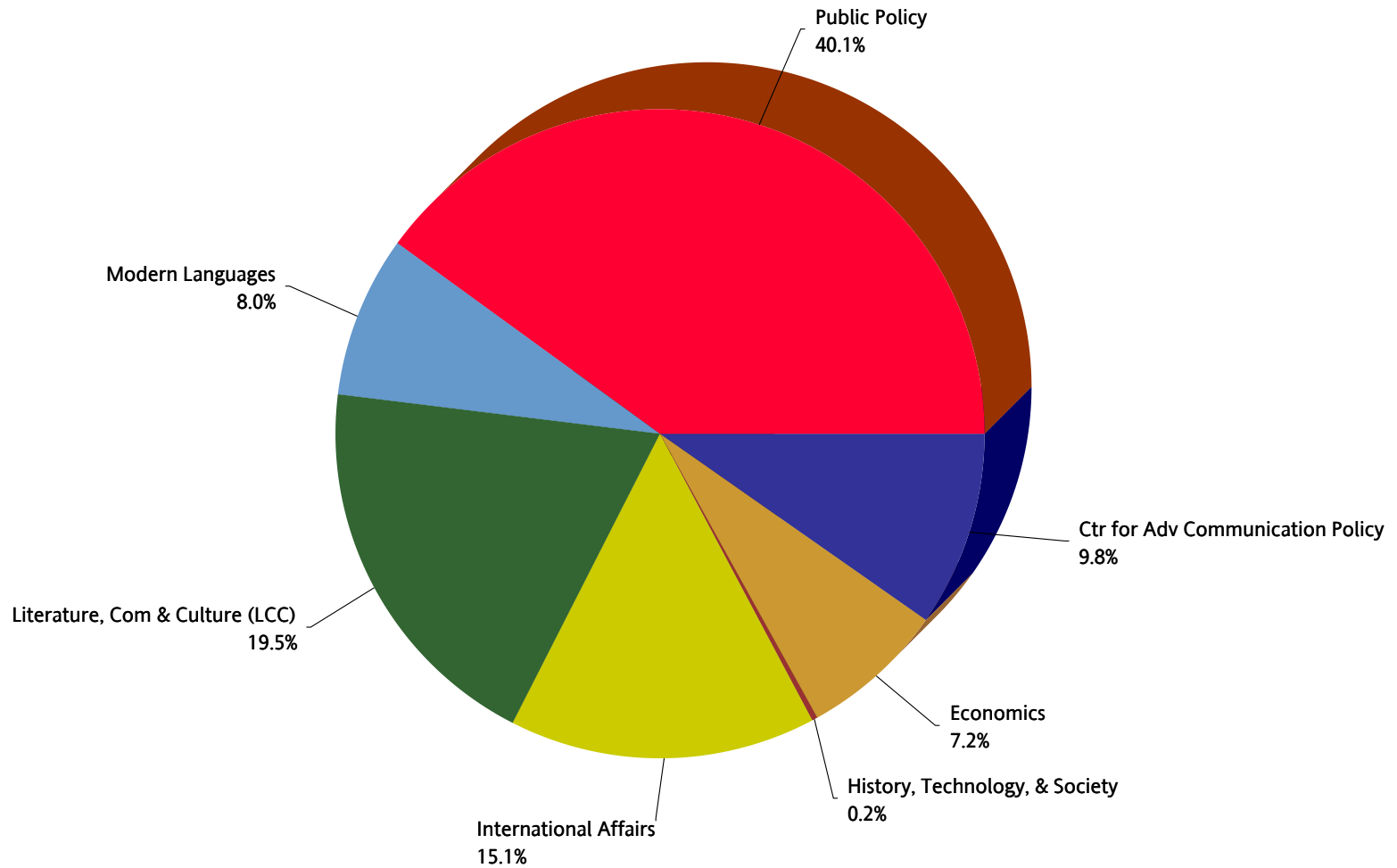
